In accordance with the directives by Director of Education, vide Circular No. DE.15(431)/PSB/2025/9744-9752 Dated: 24/12/2025, Government of National Capital Territory of Delhi, Directorate Of Education: Private School Branch Old Secretariat, Delhi-110054 regarding fee regulation, wherein it has been mandated that every school is required to constitute a **School Level Fee Regulation Committee** for the academic year 2025-26 on or before 10.01.2026, by selecting members of the Parent-Teacher Association through a fair and transparent process.
